## THE STORY SO FAR...

Welcome to this investment prospectus to support Neirin Teifi Evans, 16, a dedicated and passionate young racing driver – a unique opportunity to invest in grassroots sporting talent whilst also benefitting from an array of HMRC approved taxation benefits.

Unusually in this sport, Neirin only started racing at the age of 13, but his skill and dedication rapidly became apparent. Within 2 months of driving his first kart indoors, he was invited to join the Castle Coombe Circuit Autumn Junior Championship, and just a few months later, he tested on Silverstone's F1 SIM and became the third fastest driver ever, quicker than the current F1 reigning champion Max Verstappen.

He then successfully test drove for the Daniel Ricciardo Series to compete in the 2022, 2023 and 2024 karting seasons, reaching the World Karting Finals in Milan in 2023.

Neirin is currently signed to Arden International, owned by the renowned Horner family and the sister team of Red Bull Racing. Arden have been

instrumental in developing young drivers, having coached Sergio Perez, Carlos Sainz and Oscar Piastri, who are three of the 20 drivers currently on the Formula 1 grid. On a monthly basis, Nye attends the Young Racing Drivers Academy (YRDA) at Arden HQ in Banbury for professional Sim training with Steve Hutchinson, a highly experienced driver/coach who not only works for Arden but also for Red Bull Racing, Mercedes AMG F1 and Alpine.

Neirin is also mentored by former Formula 2 driver Calan Williams, an Australian international racing driver who is competing in the GT World Challenge Europe Endurance Cup with Belgian BMW M Team WRT. Calan's support and direction have been influential in assisting NT Racing shape its strategy. Neirin is balancing his racing career with his A Level studies at the prestigious Radley College, where he is President of the F1 Society.

**Neirin is now seeking investment to propel him to the next level of UK Motorsports – Formula 4.**

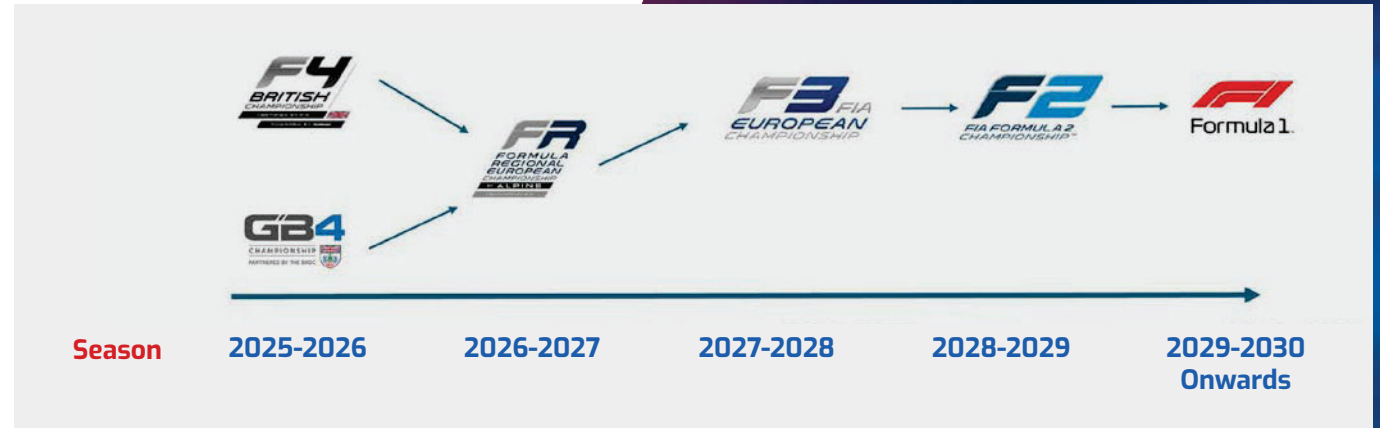

# A WINNING TEAM

## The Strategy

Whilst Formula 1 is the global phenomenon that is the undisputed pinnacle of global motorsports, there are several feeder routes to reach that highly competitive level. Neirin Teifi will be testing for Formula 4 in early 2025, with a 6-year career plan to progress through the UK motorsports ranks via F.RECA, F3 and F2 then onwards to Formula 1:



## The Series

FIA Formula 4, also called FIA F4, or F4, is an open-wheel racing car category intended for junior drivers. The category was created in 2013 by the Fédération Internationale de l'Automobile (FIA) - the International sanctioning and administrative body for motorsport - after approval by the World Motor Sport Council as an entry-level category for young drivers, bridging the gap between karting and Formula 3, and enabling drivers as young as 15 years of age to race on some of the most challenging and renowned circuits in the world. As the championship is certified by the FIA, 12 Super Licence points will be awarded to the overall champion to aid their progression through the single seater ranks.

Having previously launched the careers of legends including Ayrton Senna, Michael Schumacher, Damon Hill, Eddie Irvine, Jenson Button, David Coulthard and more recently McLaren F1 star Lando Norris, the F4 category remains the 'go-to' destination for drivers aspiring to achieve a career at the sport's highest level.

The championship has an unrivalled promotional platform to aid drivers in building their audience; British F4 receives live free-to-air television coverage on ITV4, as well as capacity trackside crowds at each of the ten events on the UK's premier circuits and impressive social media coverage to assist in building your brand.

# A TAX EFFICIENT WAY TO INVEST

## Benefitting from HMRC's Enterprise Investment Scheme (EIS)

For sophisticated investors contemplating investment opportunities, Enterprise Investment Scheme (EIS) qualifying investments provide an appealing alternative due to the many tax reliefs available. Investing in Enterprise Investment Schemes is encouraged by UK Government to raise funds for a greater number of small businesses, and this is reflected in the attractive rates of tax relief on offer.

NT Racing Investments Ltd was incorporated on 24th October 2024 with 10,000 shares, the purpose of the entity being to generate income to cover the extensive costs of a thriving motorsports career via private investment, sponsorship, grant income and potentially donations from benefactors who either have an affinity with motorsports, or sport in Wales in general.

The 10,000 shares will be released on a phased basis in tranches of 2,500 per annum as Neirin progresses from F4 to F2. The price point for the first tranche of entry level shares at F4 level will be determined once the final budget for 2025 is determined.

The principal return for the investor is a share of any future earnings which Neirin may achieve at any stage of his career, the pinnacle being F1 whereby earnings will exceed £5m per annum. The percentage of earnings attributed to each investor will be determined by the share purchase entry point of the investor, with early adopters at F4 stage securing a stake for a significantly lesser investment sum than those who invest at a later point when Neirin progresses upwards towards the end goal of F1.

## Key Points for Investors

- **Income Tax Relief** - 30% upfront Income Tax relief. There are no exclusions to this tax break and it can also be spread across the current and previous year's income tax bill. This is called a "carry-back" and it allows the investor to use any surplus income tax relief for the previous year if the current year's income tax is reduced to zero;
- **Capital Gains Tax (CGT) Deferral** – an investor can defer capital gains realised on a different asset, where disposal of that asset was less than 12 months before the EIS investment or less than 36 months after it. This relief is limited to the amount being invested into the EIS and can be claimed by investors whose interest in the company does not exceed 30%. Where gains arise on the EIS investment, taper relief is available;
- **CGT Reinvestment Relief** No CGT to pay on any gains made when the investment is realised after three years provided the EIS initial income tax relief was given and not withdrawn on those shares;
- **Loss Relief** – if EIS shares are disposed of at any time at a loss, such loss can be set against the investor's capital gains or income in the year of disposal,
- **Inheritance Tax Relief** - shares do not form part of the estate for Inheritance Tax purposes, provided the investments have been held for at least 2 years at time of death and the company qualifies for Business Property Relief ("BPR").

The maximum subscription is currently £1,000,000 per investor per year, yielding a potential reduction in tax liability of £300,000 per annum (assuming the investor has sufficient income tax liability)

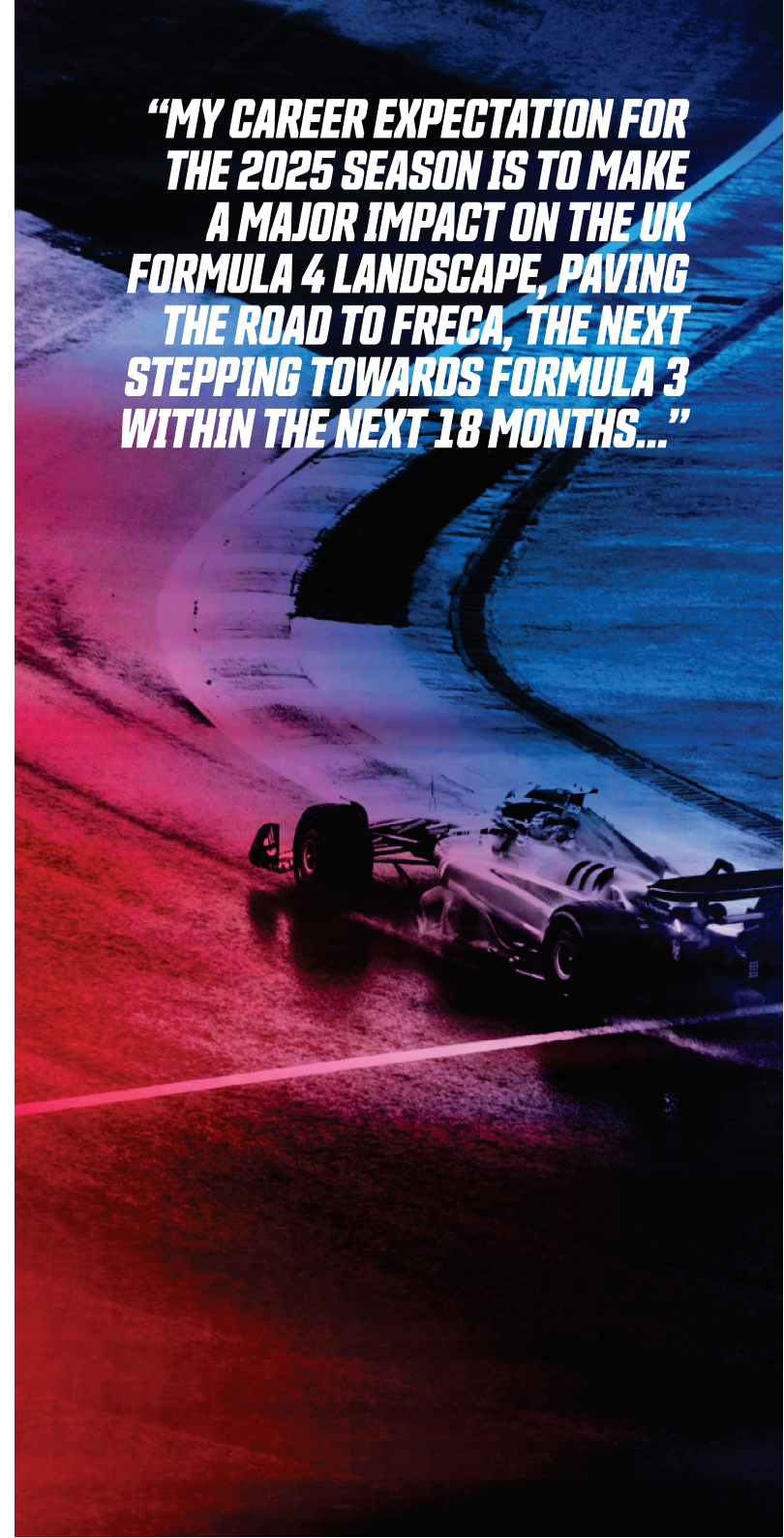
